


UK Business code of Behaviour




NHS Bodies don't need to follow the UK Corporate Governance Code (rules). We showed how we run on our business by doing things the best ways we can.

This includes the parts of the UK Corporate Governance Code we think fit our role and show we are doing things how we should.




We have used good legal advice, to ensure we obey the laws we must.






Responsibility for each duty and power has been given to a lead Director. Directors have said their structures have what they need to carry out all our legal duties.






Working with our partners




During 2019-20, we have carried on working with NHS England, with settled buying arrangements following strong rules to help the joint buying of primary care.



This includes the NHS HMR CCG Primary Care Commissioning Committee which is described in an earlier part of this report.



Difficult and unusual words

Governance – the rules used to make sure an organisations works the way it should

UK Business code of Behaviour – a document that sets out the minimum standards needed for running a business properly.

North East Sector of Greater Manchester – the partnership of Oldham, Bury and HMR CCGs

Strategic Place Board (previously Health and Wellbeing Board) and associated sub-committees -The Health and Wellbeing Board will provide for shared leadership of a strategic approach to the health and wellbeing of the Borough and its communities that reaches across all relevant organisations.

Rochdale Safer Communities Partnership – a partnership of different organisations working together to ensure our local communities are safe and healthy

Rochdale Borough Safeguarding Children’s Board – A partnership of organisations that work together to protect young people in the borough.

Rochdale Borough Safeguarding Adults Board – A partnership of organisations that work together to protect vulnerable adults in the borough.

Rochdale Borough Children and Young People's Partnership – a partnership of organisations looking after the health and wellbeing of children and young people in the borough

Joint Executive Leadership and Wider Leadership Team – the group of top managers who work together to run Rochdale BC and HMRCCG

Local Care Organisation Board – the group of people who look after the running of the local care organisation
